### Donor Spotlight

In October 2022, HSP learned that it had been named the sole beneficiary of the estate of Mr. James Serl Ritchie. Mr. Ritchie lived his life in Superior, Wisconsin, but had deep family ties to early Philadelphia and a passion for the Ritchie legacy. We honored Mr. Ritchie's generosity by investing in HSP's future and sustainability through endowment growth and other strategic initiatives.

## Education

#### **HSP Leads National History Day Philly**

In 2023, HSP became the steward of National History Day (NHD) Philadelphia, the local affiliate competition of National History Day, an award-winning academic program that helps develop lifelong critical thinking skills and civics participation.

Hosted at the National Constitution Center in March, the competition was held in-person for the first time since 2019. Philadelphia students from 6th through 12th grade chose a topic related to the theme "Frontiers in



History," which they then used to produce a paper, documentary, website, exhibit, or performance. 108 students from across the city presented their projects. From that group, 44 students went on to Pennsylvania's state competition, followed by 11 students qualifying for the national competition.



Preparation for the program focused on reengaging with a large network of schools, teachers, museums, and volunteers. Under HSP's new leadership and with the help of 3 new steering committee members, 22 partner institutions, and 79 day-of volunteers, NHD was a successful and inspiring event.

One student reflected on the event, saying, "The NHD process taught me so much, such as how to research, how to create a documentary, and how to structure an argument. I was able to dive into a topic that I enjoyed researching, and I think that all [students] could benefit academically from exploring a topic that they themselves choose." A program like NHD is uniquely poignant in Philadelphia where every participating student is surrounded by reminders of their place in history. The competition provides them with the chance to engage with the past, work towards a goal in collaboration with others, and develop skills that will serve them in the future.

# Highlights

#### **HSP** Renovates Interior

HSP's last annual report announced the start of a comprehensive exterior renovation and lighting project. The successfully completed project received a Grand Jury Award from the Preservation Alliance of Greater Philadelphia this year. A complete restoration of the building's stone and brick facade resolved moisture issues and a new exterior lighting concept illuminates the building's beautiful architecture. HSP continued its capital improvements in 2023, focusing on the interior of its 114-year-old building, specifically the public-serving spaces on the first and second floors.



HSP's lobby and Information Commons were reconfigured with an open layout, classic furnishings, and warmer lighting to improve the functionality and aesthetic of the public spaces. A stunning mural of a 1796 map of Philadelphia adorns the lobby's western wall illustrating the city's expansion in its first century. Updated technology includes new

computers and improved Wi-Fi to provide a quality research experience for all patrons.

Renovations to the second-floor Patterson Room equipped the room to serve as a multi-purpose space for lectures, meetings, seminars, and parties (including event rentals) with updated projectors, screens, and speakers. The removal of old bookshelves, a paint job, and new carpeting freshen the room. With its new layout, HSP can carry out impactful programming with improved accessibility and seating options to accommodate hybrid programming and larger audiences both in-person and virtually.

HSP will continue its capital improvements with a critical IT infrastructure upgrade throughout the building to improve staff efficiency, data security, and reliable access to HSP's numerous catalogs and databases. HSP is grateful to the donors who continue to invest in HSP's future by making this important and necessary work possible.

#### Engaging with the Public



Through a dynamic blend of hybrid, virtual, and onsite programming, HSP hosted over two dozen events featuring over 40 presenters. These programs ranged from genealogy workshops to history-focused events, including a walking tour exploring the 1838 Black Metropolis and the Dickinson Symposium, co-hosted with the American Philosophical Society, the Library Company of Philadelphia, and the McNeil Center for Early American Studies.

HSP also strengthened its partnership with the Genealogical Society of Pennsylvania, hosting a two day

seminar called the Family History Sampler. This hybrid event featured three top genealogy experts who offered research insights on accessing and interpreting historical records.

Other program topics spanned a wide range, covering women's history, Black history, Asian history, early American history, and Philadelphia politics. These programs served over 1,000 attendees, deepening their understanding of the past, while offering new perspectives on the present.



### Preparing for our 200th Anniversary



In a continued effort to prepare for the upcoming 200th anniversary, HSP's editorial team worked closely with historians and experts from around the country to compose *Two Hundred Years: The Historical Society of Pennsylvania, 1824-2024*, an edited book which highlights the best of what our collection has to offer.

The volume features 100 items (from our collection of over 21 million), selected to shed light on the unique verity and lasting importance of HSP's collections. The team of authors containing top scholars, Pulitzer-prize winning historians, and local academics dove deep into the history and context of the chosen items to reinterpret old favorites and identify those which may have been unfamiliar.

Published in October 2023, this text will serve as great tool for continued scholarship, promotion, and stewardship as we enter HSP's third century..

# Around the Library

### **HSP Expands and Cares for Collections**


HSP is recognized in the research community for the depth and breadth of its archival collections, but many are not aware that HSP is an actively collecting special collections research library. In the past year, HSP accessioned 27 new collections (totaling over 170 linear feet).

Collections can range in size from a single photograph or map, to dozens of boxes of family papers or institutional records. One



example is the donation of the Montgomery, Scott, Wheeler Families papers encompassing 103 boxes, 142 volumes, and 11 flat files. The collection contains letters, diaries, business records, architectural drawings, photographs, scrapbooks and more. These documents trace the family's contributions to the Pennsylvania Railroad, the legal and banking

professions, military service, the arts, dairy farming, fox hunting, social histories, and many other topics.



Continuously adding to the breadth and depth of its collections will continue to keep HSP relevant in our 200th year and beyond.
